In Accordance with the Town of Beaufort Code Chapter 91.03, all outdoor entertainment permits issued allowing sound-amplifying equipment to create outdoor amplified sound shall expire at 10:00 p.m. each night; however, upon application of a non profit organization sponsoring a cultural event open to the general public on a fee or non-fee basis, the amplifying equipment will expire at 12:00 midnight on the condition that amplified sound not be used after 10:00 p.m. by the non profit organization more than four nights per year.
